

It's been an interesting 6 months... since Neighbourhood Watch Scotland joined the Scottish Community Safety Network in a pioneering new partnership.

A partnership that brings together 2 significant community safety organisations together under a single Chief Executive Officer (me), with some shared backroom functions and a common goal to support safer communities across Scotland.

In our first 6 months we have brought 2 staff teams together; strengthened governance; recruited a new Chair; submitted aligned budgets to the Scottish Government; created a single communications plan and joined up our payroll provision. And all of this while Brexit and Covid-19 have provided an unprecedented backdrop.

When we were starting to think about what each other organisation could bring to the

partnership - we expected to see some mutual benefits around shared information, extra contacts and links - NWS wanted access to SCSN's strategic partnerships and development capacity and SCSN saw the advantages of access to communities through the watch and alert systems. It's been much more that that though. We have plans to jointly deliver focus groups in communities that can enable frontline community safety issues to directly inform partnership strategy and action. Well we did - until Covid came! Like other third sector organisations we have had to adapt. Put on hold some of our exciting plans. And do something different. So, now we are working more

closely than ever before with the Building Safer Communities executive group to use our alert system to disseminate new types of information out to all our members and users and also to be able to inform the development of Covid community responses. Our staff team are working from home, keeping safe. And our board are meeting virtually to ensure that Governance continues. We are fortunate to be able to do this. And we are grateful to our funders to allow us to be so agile and responsive. So, while the day to day work continues the plans remain in place to continue to align both organisations closer together to make sure that the communities we serve continue to be safe.

SelectaDNA is not only being used by 1,000s of householders throughout the UK to prevent and deter housebreaking, but also by many schools, hospitals and businesses that own expensive and vital equipment.

SelectaDNA Home Kits are now being offered to members of Neighbourhood Watch Scotland as part of a new partnership to reduce housebreaking.

ALERTS have been sent out and directly received by 1.8M individuals

We have also noticed a significant increase in new registrations for ALERT and indeed new Watch areas being set up. During May alone we have had 20 new Watch areas starting up across Scotland with daily enquiries from more asking how to get started.

We feedback this information weekly to the Scottish Government and Building Safer Communities Partners.

Our biggest asset is however you and we know the fantastic work and support you are all doing to make our communities safe. We can make a difference if we continue to look out for and care for each other.

Varrie, Mark and myself would like to thank you for your ongoing support and once lockdown is over look forward to planning our NWS Roadshow where we will be travelling out across Scotland to various venues to meet up face to face with our co-ordinators and members. Secured by Design (SBD) is the widely respected and long-established official police security initiative operated by the Police Service across the UK.



SBD provides a recognised standard for all security products that can deter and reduce crime and keep you safe - Police Preferred Specification.

Since SBD launched in 1989, SBD have worked with businesses to encourage innovation to deter and reduce crime, constantly adapting crime prevention advice to keep pace with changing patterns of criminal behaviour.

SBD is the only way for companies to obtain police recognition for security-related products in the UK.

What practical benefits does this bring for you?

SBD accredited products will reduce the likelihood of you becoming a victim of crime and help keep you safer.

A Police Scotland study (2017) of 3,000 housing association homes built on more than 150 developments in Fife, East Central Scotland, over the last 20 years found reductions in crime of 87% every year.

Because products are robust, they will last longer too.

Studies led by the University of Surrey (2016-17) have found that SBD is good for the environment too. Burglary prevention measures installed individually or in combination, were found to produce less carbon emissions than an incidence of burglary.

When buying security related products, what should you be looking for? How do you know that a product is sufficiently robust to do the job you want it to do? What should you be asking for?

- When buying security related products always ask for SBD recognised products
- Look out for the SBD police security initiative logo on security related products, because only SBD member companies can use it
- Check on the SBD website. There is a wealth of information on the SBD website, including a list of 5,000 products in over 30 different crime categories that have been recognised as having achieved Police Preferred Specification. If it's not on the website it's not SBD.

SBD accredited products include doors, windows, external storage, bicycle and motorcycle security, locks and hardware, asset marking, alarms, CCTV, safes, perimeter security products and many others visit www.securedbydesign.com.



Some easing of lockdown restrictions has meant that people in Scotland can now meet others from another household in outdoor spaces. Additionally, some leisure activities including fishing and kayaking are now also being allowed – if socially distancing and handwashing is adhered to. Although this is positive news, it is important to remember the risk that beaches and inland waters can pose. Cold Water Shock is a real concern especially as, with all the hot weather we have had this spring and summer, it can be tempting to jump into cold water to cool off. However, this sudden immersion makes you gasp and breathe in water which can lead to a fatal drowning.



ACCORDING TO SCOTLAND'S DROWNING PREVENTION STRATEGY, 40 PER CENT OF **PEOPLE WHO DROWN EVERY** YEAR IN SCOTLAND DO SO **UNINTENTIONALLY IE THEY** WERE WALKING OR CYCLING **NEAR WATER AND FELL IN.**

If you do find yourself in this situation, it is extremely important that you stay calm and float on your back until you can regulate your breathing again. Plan ahead if you are going to be taking part in any exercises or activities that will take place in or around water and assess the potential risks for everyone in your household or anyone else who will be accompanying you. Talk to your children and your family about the potential dangers of open water as Cold Water Shock can affect even the most experienced swimmer. In addition, continue to follow government advice and stay local. If you do not live near the beach or other waterways, don't travel there and continue to help take tension off our emergency services.

For the Scottish Partnership Against Rural Crime, (SPARC) the past year proved to be eventful, influential and productive with Rural Watch Scotland at the core of both the national and all local partnerships against rural crime groups.

SPARC published Scotland's first rural crime strategy which provided a clear vision, aim, four objectives and seven priorities with a focus on tackling serious organised crime. This template enabled the 13 territorial policing divisions to model their local partnerships with the same structure and thus create a more cohesive, professional and tangible approach, regardless of geographic location.

Priority was given on ensuring firstly those living, working and enjoying Scotland's rural communities and environments had confidence any crime related issues affecting them were taken seriously, acted upon and understood and secondly raise awareness and increase visibility of SPARC throughout Scotland.

Through establishing new, whilst strengthening existing, local rural crime prevention groups within Local Authority and/or policing divisions across Scotland where issues raised locally can be understood, tackled and resolved locally, Rural Watch Scotland was recognised as the mechanism to help rural communities communicate, be better connected and informed plus feel safer. Particularly heartening has been the number of individuals signing up to Rural Watch Scotland and momentum has gathered pace as the benefits of the Alert system have produced results.

In terms of increasing visibility, from April -September 2019, working in conjunction with Valtra and the Hamilton Ross Group, a tractor and Rough Terrain Vehicle which were marked up in police livery to assist in conveying this objective throughout Scotland were loaned to SPARC.

> We managed to attend a total of 49 agricultural events and shows leaving a footprint in all 13 territorial policing divisions and 23 local authority areas. Such was the positive feedback, interaction, media coverage and response, members of SPARC were invited to bring the initiative to a conclusion at the Scottish Parliament where numerous MSP's from all parties attended a photographic opportunity on

how rural crime is being prevented and tackled in Scotland.

Another highlight was the launch of the Scottish Heritage Crime Group, a sub group of SPARC which has been formed with the remit of developing a strategy around protecting Scotland's 6 UNESCO World Heritage sites plus several thousand cultural and historic sites.

Currently and undoubtedly due to COVID-19 restrictions, throughout Scotland there has been a significant reduction in reported rural crime throughout Scotland however SPARC is already preparing its focus for the remainder of the year with forestry and flytipping high on the priority list.

Here are some general tips to help you stay Scam Aware (find lots more advice and links to trusted sources of information on our website):

Doorstep Scams

Never feel obliged to answer the door to a cold caller

Take time to think before making a decision - don't agree to make any payments on the doorstep

Do plenty of research into a company before dealing with them - get 3 quotes from trusted traders* and check 3 different review sites

1 Phone Scams

Don't press 1 or follow instructions given in an automated message

Don't give a cold caller remote access to your computer

Never give personal or financial information to a cold caller. If in doubt, hang up, clear the line and call them back using a number found on a bill/statement or their website.

Email Scams

Don't click on links or open attachments in emails from unknown senders

Be wary of official-looking emails asking for financial details or payments always verify that these are genuine before clicking on links or entering any details

Don't make purchases or charity payments via a link in an email from an unknown sender

Online Scams

Be wary of surveys on social media - you don't know who you are sending your personal details to


Be wary of pop-up adverts, particularly if items are advertised at a price that is significantly cheaper than on official websites

When buying goods or services online, pay by credit/ debit card or PayPal if possible rather than bank transfer. This will offer more protection if you are a victim of fraud.

- Report fraud or suspicious activity in your community to Police Scotland on 101 or 999 in an emergency

Over the coming months Neighbourhood Alert will be getting an upgrade. VISAV the company who supply us with the software are in the process of finishing the development of V4 and looking to

role this out to us shortly. The team at Neighbourhood Watch Scotland and all the administrators across Scotland are looking forward to these developments which will enhance our ability to deliver high quality information and advice to all our registered users.
